AN ACT

RELATING to Motor Vehicles; Providing That Application for Title for Motor Vehicle State That the Vehicle is Equipped With Approved Emission Control Device, and Amending Section 28-303, Arizona Revised Statutes.

1. **Be it enacted by the Legislature of the State of Arizona:**
2. Section 1. **LEGISLATIVE INTENT**
3. To assure a clean and wholesome atmosphere, all sources of pollution
4. must be contained and abated. It has been established that internal
5. combustion engines as employed in automobiles are the major source
6. of pollutants in the state of Arizona. Scientific developments have,
7. however, established methods of restricting these emissions. Therefore,
8. for the health and safety of all citizens in the state of Arizona, the
9. legislature intends by this legislation to assure that all motor vehicles,
10. new or used, will be equipped with emission control devices, that the
11. state board of health establish standards for them, and that certificates
12. of title would be issued only when the subject motor vehicle is
13. equipped with such device or devices.
14. Sec. 2. Sec. 28-303, Arizona Revised Statutes, is amended to read:
15. **28-303. APPLICATION FOR CERTIFICATE OF TITLE**
16. A. Application for a certificate of title to a motor vehicle, trailer or
17. semitrailer shall be made to the assessor of the county in which the
18. owner resides upon a form furnished by the vehicle division. The
19. application shall be signed by the owner and shall contain:
20. 1. The owner's complete residence address.

1. 2. A brief description of the vehicle to be registered.
2. 3. The name of the manufacturer of the vehicle.
3. 4. The engine and serial number of the vehicle.
4. 5. Whether the vehicle is new or used.
5. 6. The last license number if known and the state in which issued.
6. 7. If the application is for a certificate of title to a new vehicle, the
7. date of sale by the manufacturer or dealer to the person first operating
8. the vehicle.
9. 8. AN AFFIRMATIVE STATEMENT INDICATING THAT THE
10. MOTOR VEHICLE IS EQUIPPED WITH AN EMISSIONS CONTROL
11. DEVICE THAT MEETS THE STANDARDS ESTABLISHED BY THE
12. STATE BOARD OF HEALTH.
13. 78 / 9. Other information required by the vehicle division.
14. B. The application for a certificate of title to a new vehicle shall be
15. accompanied by a certificate from the manufacturer showing the date
16. of sale to the dealer or person first receiving it from the manufacturer,
17. the name of the dealer or person and a description sufficient to identify
18. the vehicle, and certifying that the vehicle was new when sold. If sold
19. through a dealer, the dealer shall certify that the vehicle was new when
20. sold to the applicant.
21. C. If the application is for a certificate of title to a specially
22. constructed, reconstructed or foreign vehicle, such fact shall be stated
23. in the application. With reference to every foreign vehicle which has
24. been registered in another state or country, the owner thereof shall
25. surrender to the vehicle division the number plates assigned to the
26. vehicle, the registration card and certificate of title, certificate of
27. ownership or other evidence of foreign registration, together with
28. satisfactory evidence of ownership showing that applicant is the lawful
29. owner or possessor of the vehicle.
30. D. When in the course of interstate operation of a vehicle
31. registered in another state or country it is desirable to retain
32. registration of the vehicle in the other state or country, the applicant
33. need not follow the requirements of subsection C of this section but
34. shall submit for inspection evidence of the foreign registration and
35. ownership, and the vehicle division upon a proper showing shall register
36. the vehicle, but shall not issue a certificate of title for it.
37. E. A foreign vehicle, before it may be registered in this state, shall
38. be examined and inspected by the vehicle division or an officer or agent
39. thereof, including examination and inspection to establish compliance
40. with Section 28-955 under such conditions and standards as may be
41. required by the state board of health.
42. F. An applicant who rents, or intends to rent the vehicle without a
43. driver shall state that fact in the application.
