RELATING TO ELECTIONS; PROHIBITING CONTRIBUTION BY LABOR ORGANIZATION TO IN-FLUENCE ANY ELECTION, AND AMENDING SECTION 16-471, ARIZONA REVISED STATUTES.

Be it enacted by the Legislature of the State of Arizona:

Section 1. Section 16-471, Arizona Revised Statutes, is amended
 to read:

## 16-471. Prohibition of contributions by corporations or labor organizations; penalty

A. It is unlawful for a corporation organized or doing business
in the state OR A LABOR ORGANIZATION to make any contribution of money,
EXPENDITURE or anything of value for the purpose of influencing an
election.

B. A LABOR ORGANIZATION OR ANY OF ITS MEMBERS SHALL NOT REQUIRE

 CONNECTION WITH SUCH LABOR ORGANIZATION'S POLITICAL EDUCATION OR PUBLIC
 COMMENT ACTIVITIES OR PROGRAMS.

1 C. EVERY CORPORATION OR LABOR ORGANIZATION WHICH MAKES ANY CON-TRIBUTION OR EXPENDITURE IN VIOLATION OF THIS SECTION SHALL BE FINED 2 3 NOT MORE THAN FIVE THOUSAND DOLLARS. EVERY OFFICER OR DIRECTOR OF ANY CORPORATION OR OFFICER OF ANY LABOR ORGANIZATION WHO CONSENTS TO ANY 4 5 CONTRIBUTION OR EXPENDITURE BY SUCH CORPORATION OR LABOR ORGANIZATION AND ANY PERSON WHO ACCEPTS OR RECEIVES ANY CONTRIBUTION IN VIOLATION 6 7 OF THIS SECTION SHALL BE FINED NOT MORE THAN ONE THOUSAND DOLLARS OR IMPRISONED NOT MORE THAN ONE YEAR, OR BOTH. A PERSON WILFULLY VIOLAT-8 9 ING THIS SECTION SHALL BE FINED NOT MORE THAN TEN THOUSAND DOLLARS OR 10 IMPRISONED NOT MORE THAN TWO YEARS, OR BOTH.

D. FOR THE PURPOSES OF THIS SECTION "LABOR ORGANIZATION" MEANS ANY ORGANIZATION OF ANY KIND, OR ANY AGENCY OR EMPLOYEE REPRESENTATION COMMITTEE OR PLAN, IN WHICH EMPLOYEES PARTICIPATE AND WHICH EXIST FOR THE PURPOSE IN WHOLE OR IN PART OF DEALING WITH EMPLOYERS CONCERNING GRIEVANCES, LABOR DISPUTES, WAGES, RATES OF PAY, HOURS OF EMPLOYMENT OR CONDITIONS OF WORK.
